- (i) The District Fisheries Development Officer, Hojai District hereby invites online Bids from eligible Bidders following **two-bid system** of bidding for supply of goods/item(s) as detailed below:

- (ii) Open Competitive Bidding method shall be followed for selection of most preferred bidder for the tendered Item(s). The tender terms, conditions and procedures are in conformity with "The Assam Public Procurement Act, 2017" and "The Assam Public Procurement Rules, 2020" as amended from time to time.
- (iii) The Bidding Documents can be downloaded by any prospective bidders from the Procurement portal i.e. <http://assamtenders.gov.in> free of cost.
- (iv) All Bids must be accompanied by Bid Processing Fee of Rs. 540 (Rupees Five Hundred Forty only) and Bid Security of the amount as specified for the item(s) bided, unless otherwise mentioned in the Bidding Documents. Exemptions to Bid Security are allowed to certain class of bidders, if mentioned in this Bidding Documents.
- (v) Bids must be submitted online **as per BOQ mentioned (Group A or Group B separately)** at the e-Procurement portal (i.e., <http://assamtenders.gov.in>) on or before the due date for submission i.e. *[insert time and date]*.
- (vi) The Bidders are also required to submit the hardcopy of the Technical Bid **as per BOQ mentioned (Group A or Group B separately)** (with original documents) in

the office of the Procuring Entity within due date for submission of hardcopy of the Technical Bid i.e., [1:30 PM and 12/06/2025]. The Late Bids will be liable for rejection summarily.

- (vii) The Technical Bid will be opened online on [11:30AM and 13/06/2025] and the Price Bid shall be opened online only for the technical qualified bidders.
- (viii) The contract awarded bidder should be supplied the fish seeds in live and healthy condition in proper quantity and size to the beneficiaries in single installment as per the list provided by the DFDO, Hojai within the stipulated time.
- (ix) The contract awarded bidder should be supplied the fish feeds to the beneficiaries as per the list provided by the DFDO, Hojai within the stipulated time.
- (x) For the encouragement of local entrepreneurs, Preference will be given to the bidder of Hojai, Nagaon and Morigaon district.
- (xi) Bidders who seek to appeal against any decision, action or omission regarding this particular procurement may do so as per Section 38 of the Assam Public Procurement Act, 2017 and Rule 26 of the Assam Public Procurement Rules, 2020.
